- When submitting electronic offers, Bidders will receive an auto-reply acknowledging receipt of
 the <u>first</u> email. Should your offer require to submit more than one email, in the body of this first email,
 bidders are requested to list the number of messages, which make up their technical offer and the
 number of messages, which make up their financial offer. If you do not receive any auto-reply for the

- Any quotation submitted will be regarded as an offer by the bidder and does not

V. Overview of Evaluation Process

Quotations will be evaluated based on the compliance with the technical specifications and the total cost of the goods (price quote). The evaluation will be carried out in a two-step process by an ad-hoc evaluation panel. Technical proposals will be evaluated for technical compliance prior to the comparison of price quotes.

VI. Award

In case of a satisfactory result from the evaluation process, UNFPA shall award a Purchase Order to the lowest priced bidder whose bid has been determined to be substantially compliant with the bidding documents.

VII. Right to Vary Requirements at Time of Award

UNFPA reserves the right at the time of award of Contract to increase or decrease, by up to 20%, the volume of goods specified in this RFQ without any change in unit prices or other terms and conditions.

VIII. Payment Terms

UNFPA payment terms are net 30 days upon receipt of shipping documents, invoice and other documentation required by the contract.

IX. Fraud and Corruption
